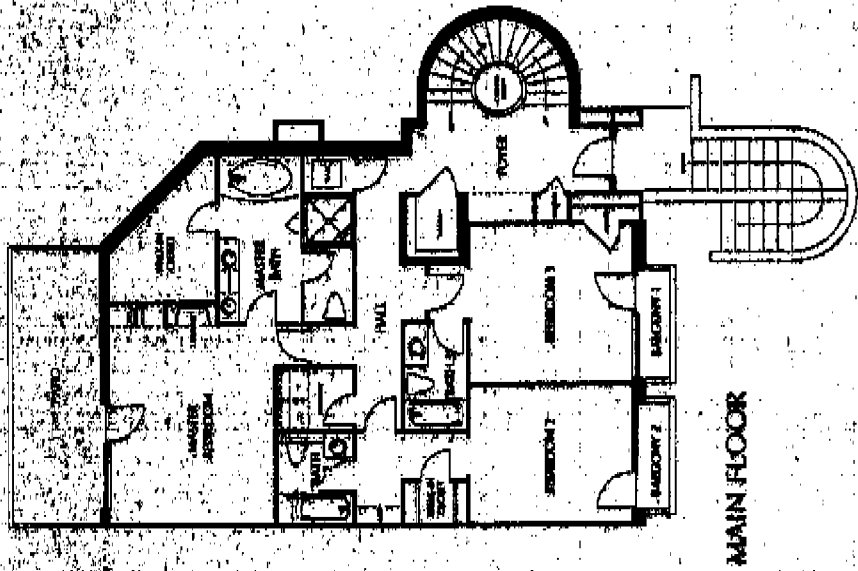
PLAN E UNIT 14

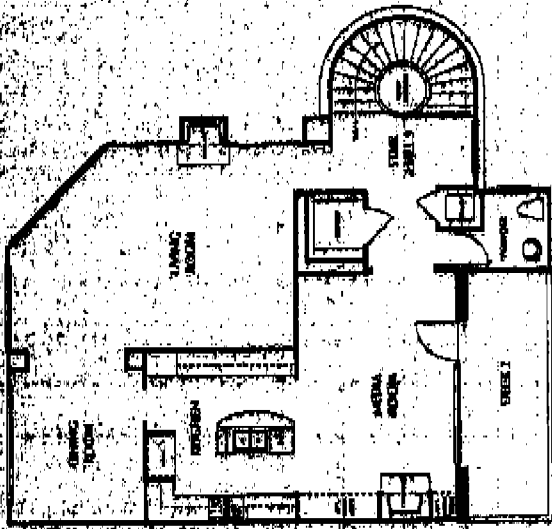

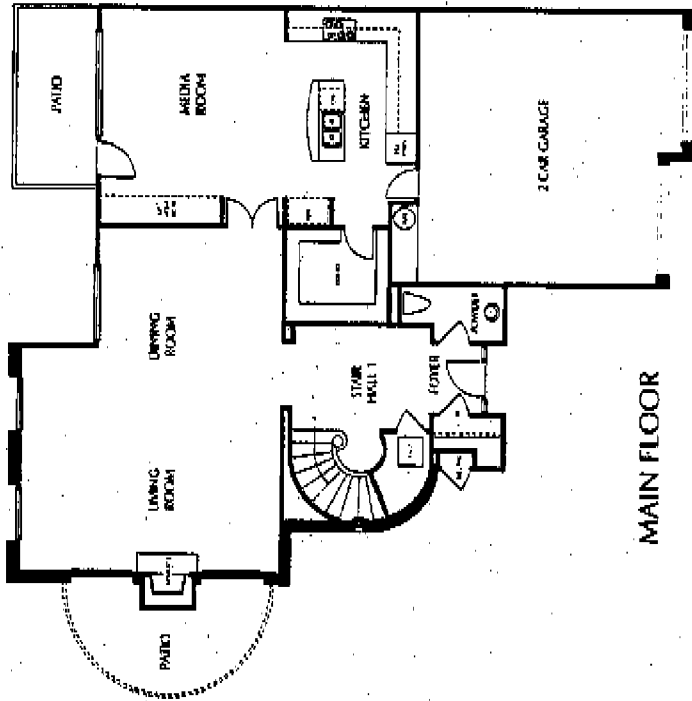

PLAN F UNIT 15

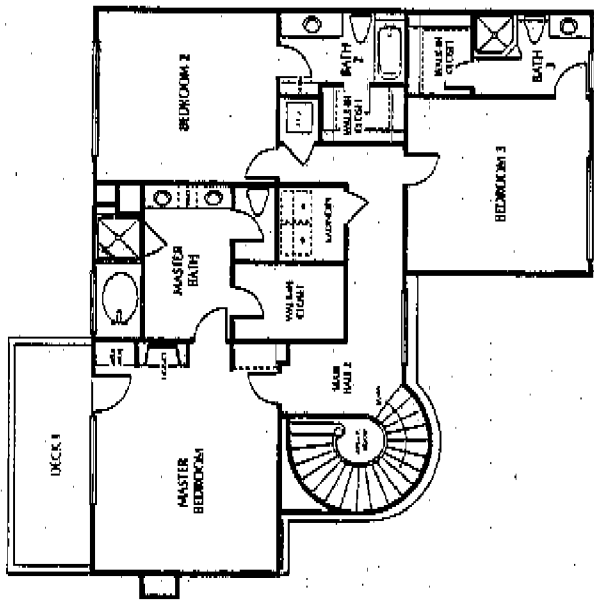
